### GLOUCESTER COUNTY BAR FOUNDATION 2025 SCHOLARSHIP FUND GUIDELINES

#### **PURPOSE**

The purpose of the Gloucester County Bar Foundation Scholarship fund is to provide financial assistance to Gloucester County high school Seniors continuing on to two or four-year colleges and universities.

#### **SCHOLARSHIP AWARDS**

Three scholarships will be awarded. The award(s) shall be based on the applicant's demonstrated scholastic ability, general character, demonstrated accomplishments and community service. Awards will be announced on May 1, 2025, at the Gloucester County Bar Foundation Law Day Luncheon. Each scholarship will be in the amount not to exceed \$1,000 and is not renewable. The three recipients will be notified prior to May 1, 2025 and will be invited along with two (2) guests to the Law Day Luncheon. It is encouraged that the proceeds of the award be used for college expenses.

#### **ELIGIBILITY**

An applicant for a scholarship award must be a Gloucester County resident and a high-school Senior who has applied to an accredited undergraduate college or university in the pursuit of a two or four year degree. The student must have lived in Gloucester County for at least one (1) year. An applicant will be deemed ineligible if a member of the applicant's immediate family is a Trustee of the Gloucester County Bar Foundation or the Gloucester County Bar Association.

#### REQUIREMENTS

The applicant must complete the application form provided by the Gloucester County Bar Foundation.

### The applicant must submit the following no later than Monday, April 14, 2025

- 1. Completed application
- 2. Copy of official transcript of high school record.
- 3. Letter of recommendation from a teacher and/or administrator of school presently attending.
- 4. Personal recommendation (not a relative).
- 5. Copy of official report of SAT scores.
- 6. A typed essay on the indicated topic.

#### **COMMITTEE**

The Scholarship Committee shall be composed of three (3) appointed members from the Gloucester County Bar Foundation.

The Committee shall review all applications and recommend awards to the Board of Trustees of the Gloucester County Bar Foundation, which will make the final decision.

#### **OTHER INFORMATION**

Applicants need not plan to pursue a career in the field of law; however, one Scholarship will be devoted to and given to an Applicant who does intend to pursue a career in the field of law or a law related/legal field.
